Location:

The premises form part of a high street retail parade and are located on the busy Goldhawk Road near to its junction with Sycamore Gardens. It is well served by transport links, including the 94/237 bus routes and is 0.2 miles (5-minute walk) west of Goldhawk Road Underground (Hammersmith & City Lines and Circle Lines). It is situated halfway between Shepherds Bush Green and Ravenscourt Park. Nearby national traders include Majestic Wine, Nisbets and Sainsbury's.

The unit is accessed from Goldhawk Road only and comprise a small retail sales area over ground floor and an additional ancillary space over mezzanine level. It benefits from two off-street car parking spaces, a glass frontage, shutters and a WC at the rear.
