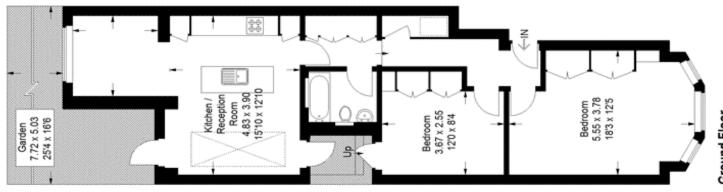




Floorplan

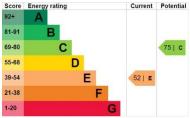
