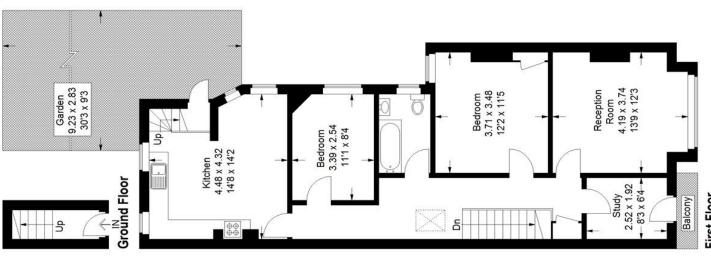


# Floorplan

## Stondon Park, SE23 Approximate Gross Internal Area

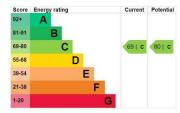
