Very well presented two bed mid terraced with fixed FIRST FLOOR staircase to a loft room (no building regs - storage only) This super property briefly comprises of gas central heating, uPVC double glazed windows, lounge and dining kitchen to 4.36m x 3.81m (14'3" x 12'5") the ground floor. The first floor affords two bedrooms and a three-piece bathroom. There is a fixed staircase to a goodsized loft room with Velux window and storage in the eaves. Externally to the front is a tarmacadam front garden and to the rear a very pleasant enclosed decked garden with Astroturf area and a raised decked patio at the foot. Situated in a popular position with access to local shops and facilities, Middleton town centre and ideal for access to the M60 motorway network.

Front aspect with laminated wooden flooring, wall mounted T.V point and radiator. Access to dining kitchen and staircase rising to the first floor.



#### DINING KITCHEN

#### 4.46m x 3.57m (14'7" x 11'8")

Rear aspect with a range of wall and base units incorporating stainless steel sink, gas hob with stainless steel extractor above, built in electric oven, space and plumbing for an automatic washing machine, spotlights, laminated wooden flooring and under-stair storage. External access.



#### **BEDROOM 1**

Front aspect with fitted wardrobes, wall mounted T.V point, carpet flooring and radiator.



#### **BEDROOM 2**

#### 2.58m x 2.32m (8'5" x 7'7")

Rear aspect with carpet flooring and radiator.



#### **BATHROOM**

Three-piece bathroom comprising of bath with rain shower above and shower off mixer taps, vanity wash-basin, lowlevel W.C, part tiled walls, laminated wooden flooring and heated towel rail.






#### **LOFT ROOM**

Accessed via fixed staircase to a good-sized loft room with Velux window, carpet flooring, radiator and storage in the eaves. (no building regs)
