| Consequences of early termination of<br>the Tenancy outside the Terms of the<br>Tenancy Agreement | If the Tenant vacates the Property prior to the end of the Term, the Tenant will<br>remain liable to pay Rent until the Term expires or the Property is re-let whichever is<br>earlier. Should the Property be re-let during the fixed Term, the Tenant will also be<br>responsible for the payment of any pro-rata commission paid in advance by the<br>Landlord for the unexpired portion of the Tenancy (this fee is calculated at 11% +<br>VAT, or 13.2% inc VAT of the Rent for the fixed Term of the Tenancy) AND if the new<br>Tenancy is for a lesser Rent, an amount equal to the difference between the original<br>Rent and new lower rental figure up to the end of the original Term. The Tenant is<br>also responsible for any other reasonable costs (e.g. telephone lines, satellite<br>television contracts, TV licences, cleaning, admin fees etc) incurred from that point<br>until the end of the Term. For the avoidance of doubt this clause shall not take effect<br>where the Tenant is operating a break clause contained in this Agreement. |
