There are a choice of excellent primary and secondary schools nearby as well as a host of beautiful parks and green spaces while Lordship Lane and North Cross Road offer an array of independent shops, bars and restaurants.

Boasting over 1,430 of internal space as well as a 23-ft low maintenance patio garden – the natural three-storey mid-terrace property has been lovingly maintained by the current owner. The ground floor benefits from an 18-ft double reception and a breakfast/dining room off of the separate kitchen. Upstairs are four comfortable double bedrooms and two recently refurbished bathrooms as well as access to the loft. There is scope for some gentle modernisation as well as an opportunity to further extend (STPP).




