Charming, bright and spacious five-bedroom family home on this desirable, residential road in the heart of East Dulwich.

Friern Road is enviably located for the excellent schools, parks and green spaces as well as easy access into The City, West End and Canary Wharf from East Dulwich station (1 mile) and Peckham Rye station (1.2 miles) with a host of bus and cycle routes through the neighbouring Camberwell, Herne Hill and Dulwich Village.

Having been tastefully modernised and extended by the current owner - the mid-terrace Victorian property boasts over 1,626 sq ft of internal space as well as a low maintenance garden. To the ground floor are two separate reception rooms, a gorgeous 19 x 15ft open-plan kitchenbreakfast room that leads through bi-folding doors onto the garden.

Upstairs, there are four comfortable double bedrooms and an additional single room or study as well as the modern family bathroom and an en-suite to the loft bedroom.







Floorplan




Garden 5.71 x 4.98 18'9 x 16'4 (Approx)


