SEPTIC TANK GENERAL BINDING RULES

Are you aware of the Environment Agency "General Binding Rules" when selling a property with a septic tank?

The General Binding Rules are a list of criteria that your septic tank drainage system must meet to be compliant. You may need to update your system to ensure it meets the legal requirements.

New septic tank rules for small sewage discharges came into force on 1st January, 2015. If your septic tank system was installed and was in use before 31st December 2014, it is classed as an 'existing discharge'. If it was installed and in use after that date, it is classed as a 'new discharge'.

The below points define an existing discharge:

- It has not changed in discharge type (from ground to surface water, or the other way around).
- · It has not been moved more than 10 metres from the original location.
- The discharge has not increased in volume since 1st January, 2015.
- · If the discharge has increased, it is still less than 2 cubic metres (2,000 litres) per day if it goes to ground, or less than 5 cubic metres (5,000 litres) per day if it goes to surface water.

A new discharge is defined as follows:

- Started a discharge from a septic tank or small sewage treatment plant on or after 1st January, 2015
- Had a discharge to surface water before 1st January, 2015 which you now want to change to discharge to ground, or the other way around.
- Had a discharge to ground before 1st January, 2015 and you want to move your discharge more than 10 metres away from the existing one.
- Had a discharge to ground before 1st January, 2015 which you now want to increase to more than 2 cubic metres (2,000 litres) per day.

A solicitor will ask for these details about your septic tank as part of the conveyancing process. Many buyers will not proceed to an exchange of contracts until the system is up to date and many lenders will also insist that the system is compliant. Therefore, it is highly advised to have your system surveyed prior to offering the property for sale.

ANIMAL HEALTH & WELFARE GRANT

Farmers and Contractors who operate livestock businesses are reminded that funding for Capital Items under the Animal Health and Welfare pathway of the Farming Equipment and Technology Fund 2023 closes on 15th June 2023.

The fund provides funding for a list of over 100 eligible items to support the specific priorities of the fund; namely financially rewarding farmers who deliver public goods, stimulating market demand for higher welfare products and strengthening the regulatory baseline. It seems that the last point is one that we should all take notice of, suggesting that funds for voluntary improvements are being made available now ahead of a possible raising of regulatory standards.

Therefore, those that see a long-term future in their livestock enterprises following the delinking of direct BPS payments, are advised to review the list of Capital items available under this fund.

Day 6 – Sunday 20th August - Whitchurch Pangbourne to
Clifton Hampden Day 7 – Sunday 3rd September - Clifton
Hampden to Swinford Bridge

Day 8 – Sunday 24th September - Swinford Bridge to Kelmscott East

Day 9 – Friday 13th October - Kelmscott East to Cricklade
Day 10 – Saturday 14th October - Cricklade to Source
