



There are strong transport links into The City and West End from East Dulwich station (0.2 miles) and Denmark Hill station (0.5 miles) as well as bus/cycle routes through the neighbouring Peckham Rye, Herne Hill and Dulwich Village.


Floorplan




Reception Room / Kitchen 8.50 x 3.97 27.11 x 13'0
