SLURRY INFRASTRUCTURE GRANT

Round 2 of the Slurry Infrastructure Grant has recently been relaunched, which will be of interest to all those whose farming system requires slurry storage. Grants between £25,000 and £250,000 are available per business for each round of the application process. These sums are paid in arrears, following completion of the works. Eligible items include above ground steel slurry stores, precast circular concrete slurry stores and earth bank lagoons. Slurry bags in excess of 2,500m3 are also included.

The grant process requires you firstly to complete the Government's Slurry Wizard Tool to calculate the storage requirements. The application will be submitted at this stage to see whether it is shortlisted. If it is, further detail is then required on the location of the slurry store. Submissions are required by 30th September 2024. If the Environment Agency then confirms everything is suitable, full applications need to be submitted by 27th June 2025.

Whilst these timeframes appear to give plenty of time to defer thinking about this, the recent wet weather should focus minds on meeting suitable storage requirements over the winter. If you require further information or support, please contact a member of the Agricultural Team.



SUSTAINABLE FARMING INCENTIVE - END OF EXPRESSION OF INTEREST REQUIREMENTS

The Sustainable Farming Incentive (SFI) is now open for applications without the need to submit an 'Expression of Interest' form to access the system. The RPA has completed the staged application roll out process which allowed them to test the RPA system.

Providing you and your land are eligible, anyone can apply for a SFI Agreement in 2023, including those with 2022 agreements. The RPA has confirmed there is no upper limit on the number of agreements they will issue this year.

To provide a boost for those who apply early, farmers who have a live 2023 agreement before the end of the year will receive their first quarterly payment – worth 25% of the annual value of their agreement – by the end of this year. Usually, the SFI payments are made quarterly in arrears.

We are actively involved in a large number of applications, so please do get in touch if you wish to discuss the SFI further, or if you would like assistance with an application.

SECTION 31(6) OF THE HIGHWAYS ACT 1980

A deposition under Section 31(6) of the Highways Act 1980 can help prevent new Public Rights of Way being established or old ones being reinstated. A landowner statement followed by a landowner declaration must be sent to the relevant County Council. The purpose of this is to record the existing Public Rights of Way, and to declare that there is no intention for any new paths being created. Once submitted, the deposition will last for up to 20 years.
