The soil is slightly acid loamy and clayey soils and is classified as Grade 3 on the Agricultural Land Classification Map.

#### Situation

The land is situated in the county of Somerset to the north of the village of Marston Magna. The town centre of Sherborne is located approximately 5.5 miles south east whilst the town centre of Yeovil is located approximately 5.5 miles to the south west. The land is accessed from Woollen Lane.


