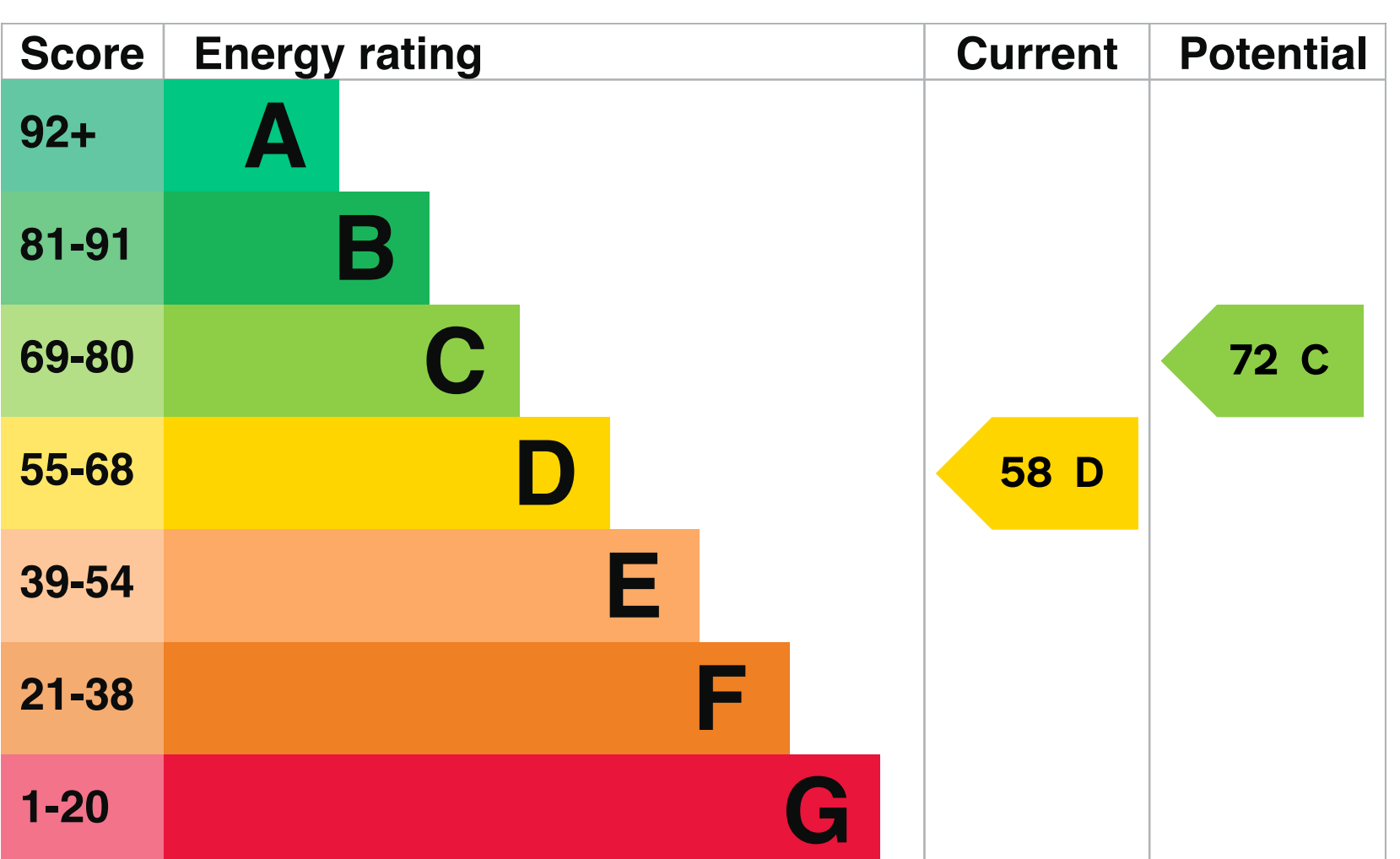

## How this affects your energy bills

An average household would need to spend **£1,429 per year on heating, hot water and lighting** in this property. These costs usually make up the majority of your energy bills. You could **save £233 per year** if you complete the suggested steps for improving this property's energy rating.

This is **based on average costs in 2014** when this EPC was created. People living at the property may use different amounts of energy for heating, hot water and lighting.

### Heating this property

Estimated energy needed in this property is:

- 19,800 kWh per year for heating
- 2,315 kWh per year for hot water

## Impact on the environment
